

## AIMS Caseload Tracker

The AIMS Caseload Tracker is a secure web-based registry for managing behavioral health caseloads in integrated care settings. It is used alongside your Electronic Health Record to provide powerful tracking and reporting functions. More information about can be found on the [AIMS Center website](#).

Please Note: This agreement must be fully executed without modification by the health care organization choosing to use the AIMS Caseload Tracker prior to gaining access or entering data into the application. The agreement includes a Business Associate Agreement in Exhibit A to protect patient privacy. Ownership of all patient data entered into the software is retained by the licensee.

If you would like to pre-pay for multiple years upfront, please email [license@uw.edu](mailto:license@uw.edu) to request an amendment to extend the agreement, which can be completed by email. Pre-payment of fees is permitted for up to five (5) years.
